
Dear Ms. Murphy:

We also need to receive the Petition For Watermaster's Services. The Petition must be signed by someone other than the Watermaster. Usually the Chairman or a Board member of the water district signs these. We have enclosed an extra Oath for the Watermaster and a new Petition for your convenience.

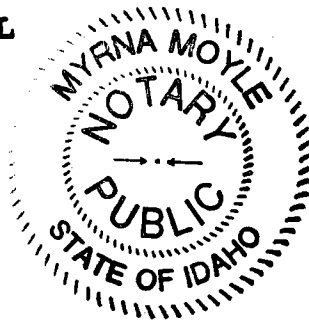
