

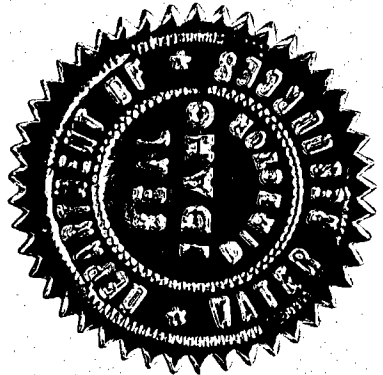

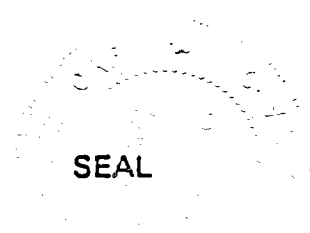
OFFICIAL OATH
