

On February 8, 2002, a *Master's Report and Recommendation Incorporating Order on Motion for Interim Administration; Order on Motion to Dismiss ("Master's Report")* was filed for the above-captioned water rights, recommending that the Court issue an order of interim administration authorizing IDWR to administer these water rights according to the *Basin 61 Director's Report*. No motions to alter or amend were filed to the *Master's Report* and the time for filing such has now expired.

Pursuant to I.R.C.P. 53(e)(2) and *SRBA Administrative Order 1*, Section 13f, this Court has reviewed the Findings of Fact and Conclusions of Law contained in the *Master's Report* and wholly adopts them as its own. Further, the Court finds that the requirements of Idaho Code § 42-1417 have been satisfied.

Therefore, IT IS ORDERED that the above-captioned water rights shall be administered in accordance with the *Basin 61 Director's Report* until such time as partial decrees are entered therefor, or upon further order of this Court.
