RESOLVED; That no ditch, canal company, or other wateruser shall have the right to demand and receive any water, and the watermaster shall not deliver to such person until the amount due and payable from such user, as fixed by the budget, has been paid.

MINUTES OF ANNUAL WATERUSERS MEETING OF WATER DISTRICT 57-R

March 6, 1995 1:55 PM

Richard Brandau called the meeting to order. Those present were; Don Eastland, representing Junayo Ranch Limited Partnership; Ed Frisbie; Henry Brandau; Tom Benson, representing Benson Farms Inc. Danny Muller; Sam Pitman; Richard Brandau; Connie Brandau; Jerry Hoagland, representing Seven High Ranch, Inc.; and Cindy Hodges, representing Idaho Department of Water Resources.

Tom Benson nominated Richard Brandau as chairman. Sam Pitman seconded. There were no other nominations. Richard was elected unanimously.

Tom Benson nominated Jerry Hoagland as secretary. Sam Pitman seconded. No other nominations were made, Jerry was elected.

The minutes of last years meeting were read and approved.

Tom Benson made motion to approve the 1994 financial report as reported by the Watermaster; Connie Brandau. Ed Frisbie seconded. The motion passed.

There was discussion of voting methods as allowed by Idaho Statute. A credentials committee could be appointed if a problem develops.

Sam Pitman nominated Connie Brandau as Watermaster. Tom Benson seconded. The Chairman requested a unanimous ballot be cast. Passed unanimously.

The Watermaster's compensation was proposed to be \$50.00 per day, \$.25 per mile. (Note: 60 or more miles per day will not be unreasonable). Ed Frisbie made motion to adopt watermaster's compensation as proposed. Tom Benson seconded. The motion passed.

Henry Brandau made motion to accept the proposed budget of \$5,000.00. Don Eastland seconded. The motion passed.

Sam Pitman made motion to retain the same advisory committee; Tom Benson and Jerry Hoagland. Henry Brandau seconded. Motion passed.

Cindy Hodges gave a report from the Idaho Department of Water Resources:

A commendation letter from Dave Tuthill for Connie Brandau's excellent Watermaster Reports, "deserves a pat on the back."

Approval of Connie Brandau's comments on the EPA's listing of "streams of concern" was appropriate as Watermaster.

Snake River Basin Adjudication:

No decision on the constitutionality of the Presumption Statutes.

The SRBA Court is beginning to hold hearings on the objections.

The legislature has made some funding available for the Adjudication.

The IDWR is proceeding with investigation of filings in other basins.


Measuring devices and control devices as required in the Reynolds Creek Adjudication of 1987, will be enforced. Connie Brandau, the Watermaster, will contact those waterusers that lack or have unacceptable measuring and control devices.

Tom Benson made motion to adopt "resolution b";

RESOLVED: That no ditch, canal company, or other wateruser shall have the right to demand and receive any water, and the watermaster shall not deliver to such person until the amount due and payable from such user, as fixed by the budget, has been paid. Henry Brandau seconded. The motion passed.

The first monday in March 1996 at 1:30 PM, in the Owyhee County Courthouse in Murphy, Idaho was set for the next annual meeting.

Richard Brandau adjourned the meeting.
