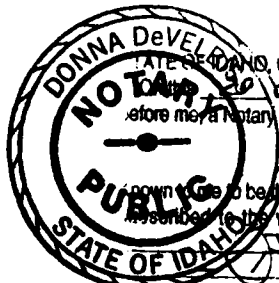

- 1> To pay attorney fees incurred in an amount not to exceed \$10,000.00.
- 2> The method of assessment is to be a \$50.00 minimum assessment per water user, with the balance assessed based on a seven (7) year average of CFS water deliveries.
- 3> The special assessment may be split or spread over up to three (3) years, subject to payment conditions negotiated."

MINUTES OF THE ANNUAL WATERUSERS MEETING OF WATER DISTRICT 57-R

Monday, March 3, 1997 1:50 P.M.

The meeting was called to order by IDWR Cindy Hodges (Chairman Richard Brandau had a prior commitment).

Those in attendance are Cindy Hodges and Kay Walker from the Idaho Department of Water Resources (IDWR); Paul Jesenko; Sam Pitman; Dan Muller; Dick Bass; and Jerry Hoagland representing Seven High Ranch, Inc.

Dick Bass was appointed temporary chairman by Cindy Hodges.

Dick Bass called for nominations for chairman and secretary. Paul Jesenko moved to retain Richard Brandau as chairman and Jerry Hoagland as secretary. Sam Pitman seconded. The motion was approved. Dick Bass would act as temporary chairman in the absence of Richard Brandau.

The minutes of 1996 annual meeting were read. Paul Jesenko moved to accept the minutes as read. Sam Pitman seconded. Motion passed.

Acting chairman Dick Bass asked for a method of voting. Sam Pitman moved for one man, one vote. Paul Jesenko seconded. Motion Passed.

Paul Jesenko made motion to hire Connie Brandau as Watermaster. Sam Pitman seconded. Motion passed.

Dick Bass asked for a resolution pertaining to collection of the budget. Paul Jesenko made motion to adopt resolution (b)

RESOLVED: That no ditch, canal company, or other wateruser shall have the right to demand and receive any water, and the watermaster shall not deliver to such person until the amount due and payable from such user, as fixed by the budget, has been paid.

Dan Muller seconded. Motion passed.

Sam Pitman made motion to set the 1997 watermaster budget at \$5,000.00. Paul Jesenko seconded. Motion passed.

Dick Bass asked for nominations for watermaster. Paul Jesenko moved to hire Connie Brandau as watermaster for 1997. Dan Muller seconded. There being no other nominations, motion to hire Connie Brandau passed.

Paul made motion to retain the same advisory committee as 1996, Tom Benson and Jerry Hoagland. Dan Muller seconded. motion passed.

There was discussion of the Schroeder bill. The resolution to establish a special budget was passed in 1996 and is a standing resolution until collected.

Cindy Hodges and Kay Walker of the IDWR reported:

- (1) The SRBA Court is issuing Partial Decrees for domestic wells and stockwater sources in Basin 57.
- (2) The IDWR will be doing GIS mapping (infrared) of irrigated lands in Basin 57, comparing claimed rights, amounts, and places of use to the actual irrigated ground. This information will be electronically coded by 40 acre tracts.
- (3) Changes of Ownership of lands and water rights need to be completed soon with IDWR if done prior to July 1996. Those since July 1996 have 180 days from the transaction.
- (4) IDWR recommends scheduling appointments at the regional offices rather than dropping in to do business.
- (5) Emergency stream channel permit waivers are available to expedite the process.
- (6) Watermaster appointment petitions and oath left with secretary.

Secretary will check on Workmen's Compensation Insurance billing for watermaster.

Dick Bass called for motion to set meeting. Sam Pitman moved to set next waterusers annual meeting for the first monday in March of 1998 at 1:30 PM in the Owyhee County Courthouse, Murphy. Paul Jesenko seconded. Motion passed.

Meeting was adjourned.
