Dear Mary:

Based on telephone inquiries I have received from Sinker Creek water users over the past week, I have elected to proceed with your 1996 appointment as Watermaster for Water District 57D. Enclosed is an Oath of Office form which you may complete and return to John Westra, who will issue your certificate. You will remain on standby status until a formal call is received from any water user.

Also enclosed are updated Watermaster Daily Record forms. You may also use up any older forms you still have. The only substantive change on the newer form is a reduction in total amount for Hulet's 6th-ranked right no. 57-00181, from 400 cfs to 54.5 cfs (for natural flows only-not stored flows). This reflects the total flow recommended to the court in the SRBA for this right. Although this decree has not yet been awarded, this modification should not be an issue since this right is rarely deliverable during the times you are on active duty.

Once you have been called to service, I will mail a letter to the water users on your behalf, setting forth your hours of availability for this coming season. Please let me know what hours you will be available 1) to receive phone calls for delivery requests or discussion, 2) to receive phone messages for the same, and 3) to make on-site deliveries. In this letter, I can also take the opportunity to reiterate our policy on acceptable expectations for Watermaster response and availability times.
