MINUTES OF THE ANNUAL WATERUSERS MEETING OF WATER DISTRICT 57-R

Monday, March 6, 2000 1:50 P.M.

The meeting was called to order by Richard Brandau, Chairman.

Those in attendance: John Romero; Tom and Jackie Benson; Connie Brandau; Richard Brandau; Angie Pline; Jan Shirts and Roxanne Brown, (IDWR); and Jerry Hoagland.

Richard called for nominations for chairman. John Romero nominated Richard Brandau as chairman. Jackie Benson seconded. There being no other nominations, Chairman Richard called for a vote and was elected.

Richard called for nominations for secretary. John nominated Jerry Hoagland as secretary. Tom Benson seconded. There being no other nominations, the Chairman called for a vote and Jerry was elected.

Copies of the minutes of 1999 annual meeting were distributed to those present, and read. Tom moved to approve the minutes. John seconded. Motion passed.

Richard asked for a treasure's report from Angie Pline. Angie reported Owyhee County transferred all money that was in the account for Water Dist. 57R, \$3682.00, to this Water District 57R to begin our own Budget account. \$1096.82 was collected for 1999 Budget charges. \$28.69 was earned from interest through 1-31-00, less expenses of \$42.75 for a cash balance on 1-31-00 of \$4764.76. \$203.89 are past due for 1999 budget. Those due are Winston Goering, \$23.70; Jim McCabe, \$1.80; Dan Muller, \$34.45; Jerry Muller, \$143.94. (Copy of Treasures Report attached to these Minutes)

Angie and Connie Brandau have not yet submitted a claim for 1999 work. Workmans Comp. is \$398.00 for a minimum policy for \$5000.00 budget. The policy covers all officers of 57R, watermaster, and watermaster assistants.

Discussion of the Schroeder Bill. If it is not paid, but watermaster assessment is paid, does water get delivered? The secretary will contact those who have not paid, and report that Reynolds Irrigation District will pay for those within that District.

Chairman Richard called for nominations for watermaster for 1999. Mike nominated Connie Brandau. Lavar seconded. Connie was elected.

Chairman Richard called for motion to adopt budget. Connie moved to adopt the watermaster's proposed budget of \$5,000.00. Lavar seconded. Motion passed.

There was discussion of moneys to pay 57-R treasurer. Treasurer will deposit funds into interest-bearing notes. Interest should cover treasurer's expenses. Will review next year.

Connie Brandau will work as watermaster at \$50 per day, and \$.25 per mile. Water district will pay State Insurance Fund-Workman's comp. (note: for next year, \$.31 per mile is common rate)

Kay Walker gave a report on activities from the IDWR. Irrigation season and conjunctive management portions of the SRBA partial decrees issued, will be notified soon for objection and response process. The Idaho Supreme Court reversed the SRBA Court and said all water rights must have a specific season of use. Barry Wood is the temporary SRBA Judge for 12-15 months. There are three finalist for permanent SRBA Judge.

Lavar made motion to retain the same advisory committee as 1998, Tom Benson and Jerry Hoagland. Mike seconded. Motion passed.

Chairman Richard Brandau called for a resolution pertaining to the collection of the Budget. Connie made motion to adopt resolution "b",

RESOLVED: That no ditch, canal company, or other wateruser shall have the right to demand and receive any water, and the watermaster shall not deliver to such person until the amount due and payable from such user, as fixed by the budget, has been paid.

Lavar seconded. Motion passed.

Chairman Richard Brandau set next waterusers annual meeting for the first Monday in March of 2000 at 1:30 PM in the Owyhee County Courthouse, Murphy.

There being no further business, meeting was adjourned.


