RESOLVED: That no ditch, canal company, or other wateruser shall have the right to demand and receive any water, and the watermaster shall not deliver to such person until the amount due and payable from such user, as fixed by the budget, has been paid.

MINUTES OF THE ANNUAL WATERUSERS MEETING OF WATER DISTRICT 57-R

Monday, March 5, 2001 1:50 P.M.

The meeting was called to order by Richard Brandau, Chairman.

Those in attendance: Tom Hook; Connie Brandau; Richard Brandau; Angie Pline; Roxanne Brown, (IDWR); and Jerry Hoagland.

There was discussion of waterusers in 57-R who have not filed claims for water in the SRBA. Those users have Decreed rights from the Reynolds Creek Adjudication and have a balance in our watermasters budget. Some of those users have indicated they are not interested in diverting water. Roxanne said the Department will be starting procedures for Basin Closures soon in some basins. Until then, waterusers still can file late claims. Our concern is they are not diverting water, so they are not being charged for the watermaster. But, they are being billed for the treasure's administration fee. That fee is exceeding their portion of the budget. We need to review the treasure's fee and budget for these users next year.

Richard called for nominations for chairman. Tom Hook nominated Richard Brandau as chairman. Jerry Hoagland seconded. There being no other nominations, Chairman Richard called for a vote and was elected.

Richard called for nominations for secretary. Tom nominated Jerry Hoagland as secretary. Connie Brandau seconded. There being no other nominations, the Chairman called for a vote and Jerry was elected.

Copies of the minutes of 2000 annual meeting were distributed to those present, Tom moved to approve the minutes. Connie seconded. Minutes approved.

Richard asked for a treasure's report from Angie Pline. Angie reported a balance on 1-31-00 of \$4,764.76. \$823.57 was collected for 2000 Budget charges. \$38.44 was earned from interest through 1-31-01, less expenses of \$625.48 for a cash balance on 1-31-01 of \$ 5,001.29. \$231.60 are past due from 2000 budget. Those due

are Benson \$16.78; Goering, \$40.48; Hall \$16.78; Heart Diamond \$16.78; Henderson \$16.78; Lewis \$16.78; Jim McCabe, \$16.78; D Muller, \$56.88; Tincher \$16.78; Tyson \$16.78. (Copy of Treasures Report attached to these Minutes)

Watermaster Connie Brandau has not yet submitted a claim for 2000 work. Workmans Comp. is \$398.00 for a minimum policy for \$5000.00 budget. The policy covers all officers of 57R, watermaster, and watermaster assistants.

Tom made motion to accept the Treasure's Report. Connie seconded. Motion passed.

Distribution of the costs for the Workmens comp. and treasure's expense are the same as last year: Water District 57R, to send bill to all members for workmans comp., treasure's wages and treasure's expenses divided equally among all water users, \$16.78 per user for 2000.

Richard called for a motion to adopt budget. Tom moved to adopt the watermaster's proposed budget of \$5,000.00. Connie seconded. Motion passed.

Connie Brandau made motion for watermaster compensation the same as last year: \$50 per day for days worked, and \$.35 per mile. Tom seconded. Motion passed

Richard called for nominations for watermaster for 2001. Tom nominated Connie Brandau as watermaster. Jerry seconded. Motion passed.

Tom made motion to retain Angie Pline for the duties of treasure at the same rate as last year, \$12 per hour (estimated total \$165 per year). Connie seconded. Motion passed.

Richard called for a resolution pertaining to the collection of the Budget. Connie made motion to adopt resolution "b",
RESOLVED: That no ditch, canal company, or other wateruser shall have the right to demand and receive any water, and the watermaster shall not deliver to such person until the amount due and payable from such user, as fixed by the budget, has been paid.

Tom seconded. Motion passed.

There was more discussion of unpaid Budget.

Discussion of stockwater.

Storage ponds not permitted and holding water from other users. IDWR recommended late claims.

Connie made motion for an advisory committee of Jerry Hoagland and Tom Hook. Tom seconded. Motion passed.

There was discussion of petition for watermaster. Tom made motion to sign petition now. Jerry seconded. Motion passed. Watermaster

will be "on" from time of petition approval by IDWR through next years annual waterusers budget meeting.

Richard called for the setting of the next waterusers annual meeting. Connie moved to set the first Monday in March of 2002 at 1:30 PM in the Owyhee County Courthouse, Murphy. Tom seconded. Motion passed.

There being no further business, meeting was adjourned.
