#### **CONDITIONS OF APPROVAL**

- 1. Proof of application of water to beneficial use shall be submitted on or before February 01, 2002.
- 2. Subject to all prior water rights.
- 3. Use of water under this water right will be regulated by the watermaster of State Water District No. 29A.
- 4. Prior to diversion of water under this right, the right holder shall install a lockable device, subject to the approval of the Department, in a manner that will provide the watermaster suitable control of the diversion.
- 5. The applicant shall install and maintain a fishway passage of a sufficient kind and capacity to accommodate seasonal movements of fish up and down the stream. The applicant shall notify the department when the passage has been completed so that its existence and acceptability can be confirmed and documented by department personnel.
- 6. The right holder shall install/maintain permanent measuring devices in such a manner that the amount of water entering the reservoir and the amount of water released from the reservoir can be measured.
- 7. Recreation storage is for a pond.
