Re: Annual meeting on March 3, 1997

Below is a summary of the Catherine Creek Water District's annual meeting.

The meeting was held at Elmer Stahle's residence. There were nine users in attendance which included one husband and wife team. The main business items and issues discussed included the following matters.

- 1) Merv Robinson was re-elected water master.
- 2) They did not approve a budget. They decided to arrive at a wage or fee for the water master if he is called to duty.
- 3) Sue Jones inquired as to whether they should not reimburse Merv Robinson for his long distance phone calls. He said it was not necessary because he only made a few calls each year.
- 4) Merv Robinson agreed to meet with Bob Thomas right after the meeting to look at the Thomas' diversion from the creek to insure that Mr Thomas understood how his water right was to be delivered from the creek and commingled with the hot water from his pond.
- 5) There was some concern expressed by Merv Robinson and several other users about how future water will be delivered to the Parkinson ranch since it has been sold and is being subdivided. Merv indicated that John Gabica, Silver Dollar Realty in Emmett and a Mr Watkins have purchased the ranch and are selling it in parcels from 10 acres to 80 acres. He said he thought three parcels have been sold but did not know the buyers. I informed the group they should advised all buyers to file a change of ownership with the department so that the claims and rights can be changed and split as necessary.
- 6) No advisory committee was elected at this meeting, if one is needed at a later date the matter can be addressed at that time.
- 7) The users in attendance are as follows: Rall Hipwell, Elmer Stahle, George and Marj Jess, Sue Jones, Bob and Kelly Thomas, Bill White and Merv Robinson.
