Below is a summary of the Catherine Creek Water District's annual meeting attended by Kay Walker and myself.

The meeting was held at Elmer Stahle's residence. The users in attendance included; Elmer Stahle, Rall Hipwell, Bill White, Merv Robinson, George Jess, and Mary Jess. The main business items and issues discussed included the following matters.

- 1) Meeting was called to order at 1:10 p.m. by Secretary, Bill White.
- 2) Bill White will remain Meeting Chairman and Secretary for 1998.
- 3) Merv Robinson was re-elected water master.
- 4) No budget was approved. They decided to arrive at a wage or fee for the water master if he is called to duty.
- 5) A question was posed about putting a dike in Hart's Creek to back it up for wildlife. We advised filing for a water right and possibly stream channel alteration.
- 6) Time for next year's meeting to be scheduled by IDWR.
