

RESOLUTIONS PERTAINING TO THE TIME AND MANNER OF COLLECTING THE BUDGET AS  
ADOPTED AT THE ANNUAL MEETING OF THE WATER USERS OF

WATER DISTRICT No. 47-0

The Annual Meeting of the Rock Creek Water District 47-0 was held March 7, 1994 at the home of Chuck & Shari Helman. The meeting was called to order by 1993 Chairman, Todd Claiborn. There were 20 members of the Rock Creek Water District Present as well as two representatives from the Department of Water Resources. Todd Claiborn was unanimously chosen to serve as the 1994 Chairman and Shari Helman as Secretary/Treasurer.

Minutes of the 1993 meeting were read and approved.

It was moved and seconded that the salaries be set, for the 1994 water-use year, as follows: Watermaster \$5000, and Secretary/Treasurer \$600.

David Crockett moved that the 1994 budget be set at \$6500. Wayland McClellan seconded the motion. Motion carried.

Repairs and maintenance of the ditches leaving the Rock Creek were discussed at it was determined that each group using the particular ditches should get together and see what needs to be done and take care of the needs.

Brent Funk brought up a concern about everyone getting their allotted portion of water when all rights have the same decree date; especially those that are on the end of some of the ditches. Again it was determined that each of these water users need to get together and find a way to alleviate this problem.

Charles E. Helman was approved as Watermaster for the year of 1994 and Amie Helman will be working as his assistant.

WATERMASTERS' REPORT:


The East Ditch approach needs to be cleaned.  
West Ditch headgate needs to be cleaned out and a heavy duty screen replaced to keep the beaver out of the culvert.  
Several individual weirs need to be improved or replaced.

David Crockett suggested that the District should authorize one person in each ditch to be responsible for what is being used in the particular ditch and report back to the Watermaster. After discussing this suggestion, Todd Claiborn agreed to once again manage the East Ditch and coordinate with the Watermaster. Charley Bean agreed to manage the West Ditch and coordinate with the Watermaster.


RESOLUTIONS:

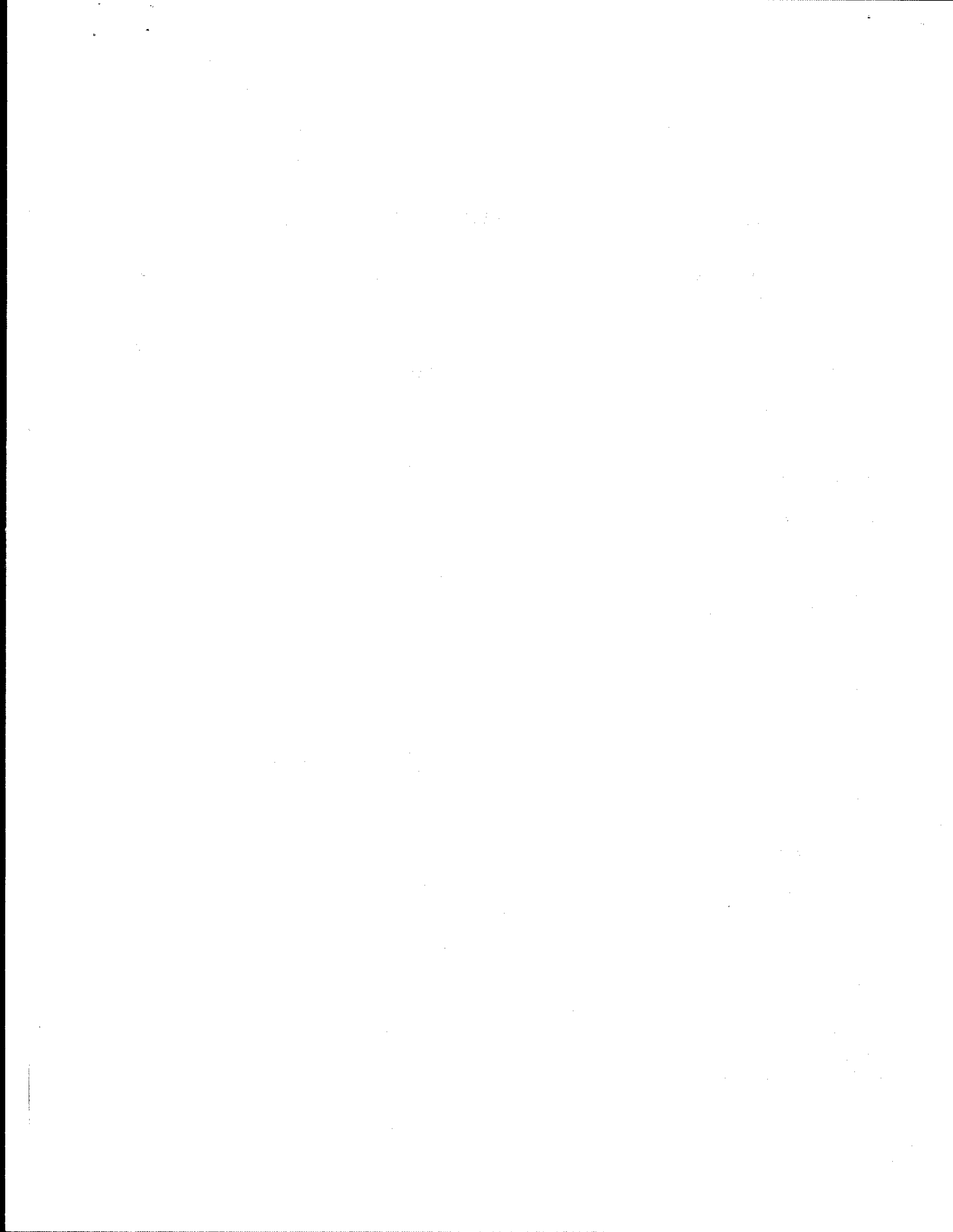

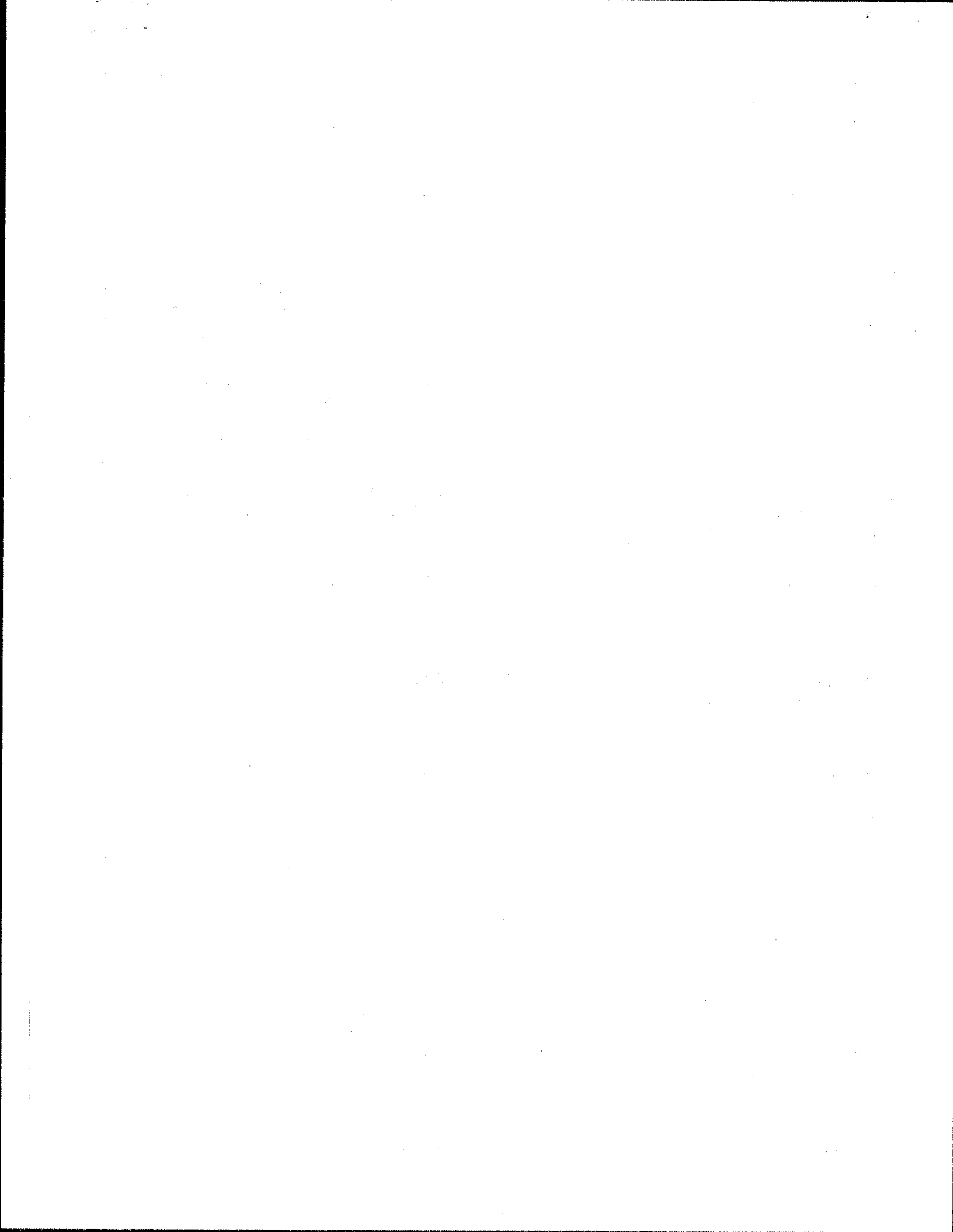
