RESOLUTIONS PERTAINING TO THE TIME AND MANNER OF COLLECTING

The annual meeting of the Rock Creek Water District 47-0 was held March 11, 1996 at the home of Chuck and Shari Helman. The meeting was called to order by 1995 Chairman, Todd Claiborn. There were 13 members present and 2 representatives from the Department of Water Resources.

The minutes of the 1995 meeting were read. Brent Funk moved that they be accepted as read; Jack Claiborn seconded ---motion carried.

Todd Claiborn, Shari Helman and Chuck Helman were unanimously elected to serve in the same capacity as last year. Todd as 1996 Chairman, Shari as Secretary/Treasurer and Chuck as Watermaster.

The Advisory Board for the year will consist of Bill Brockman as representative of the West Ditch users, Hal Frazier will represent the main stream of Rock Creek and Brent Funk for the East Ditch users.

Jack Claiborn moved that the salaries remain the same as last year. Watermaster at \$5000 and the Secretary/Treasurer at \$600. Brent Funk seconded--Motion carried.

Jeanne Robertson from the Department of Water Resources brought to our attention that each Water District is to be carrying Workers Comp on the Watermaster and any other that may be working for the District. Shari made a phone call to Boise to find that they were sending out applications in the near future to each District. It was determined after talking to Mike Jodi in Boise that our fee would be in the neighborhood of \$410.

Brent Funk moved that we go ahead and comply with the States request concerning Workers Comp and let the cushion we have planned for the account cover it for this year. Garry Nielsen seconded---Motion Carried

David Funk moved that the budget for the coming year remain at \$6000. Seconded by Garry Nielsen--Motion Carried.

There was a lengthy discussion concerning measuring devices and what was really meant by a device.

David Funk moved that we reword the motion from last year to read: Every user must have a suitable method of measuring their water, that is approved by the Watermaster and the Department of Water Resources. Any district member that does not comply will have to meet with the Watermaster and a representative from the Department of Water Resources, and make the necessary changes

before water can be delivered. Seconded by Hal Frazier---Motion Carried.

OLD BUSINESS

There was some discussion concerning what is being done on both the West and East ditches to improve the measuring out to each user there. What is being done seems to be working for the majority of the users.

NEW BUSINESS

Jeanne Robertson brought to everyone's attention to be sure that all of the water claims have been filed for the readjudication process because if not they can be lost.

RESOLUTIONS:

1. Meeting date to remain the same.
2. The minimum fee of \$20.00 was to remain the same with a serious look at this next year.
3. Billing due date will remain May 15; if not paid by that date no water will be delivered.
4. Term of watermaster seemed to be working well being extended to a 12 month period last year.
5. It was decided that all the lot owners in the Frazier Subdivision would be allowed 6 rainbirds for each 3 inch right.
