RESOLUTIONS PERTAINING TO THE TIME AND MANNER OF COLLECTING
THE BUDGET AS ADOPTED AT THE ANNUAL MEETING OF THE USERS OF

WATER DISTRICT NO. 47-0

Fourteen members of the Rock Creek Water District #47-0 met in the conference room of the Idaho Department of Water Resources' Office. The meeting was called to order by, the 2001 chairman, David Crockett. Nominations were opened for election of Meeting Chairman for the 2002 meeting.

Garry Nielsen nominated David Crockett, Second by Ed Smith. Nominations were closed and George Murphy called for a unanimous vote. Unanimous ballot carried.

Minutes of the 2001 meeting were read and approved.

Nominations for Secretary/Treasurer were opened. Hal Frazier nominated Shari Helman; George Murphy 2nd the Nomination. Garry Nielsen called for unanimous ballot. Ballot passed.

Nominations were opened for Watermaster. Hal Frazier nominated Chuck Helman, 2nd by Ed Smith. George Murphy made a motion to cease nominations, Garry Nielsen 2nd and called for a unanimous ballot. Passed.

The new advisory board for the 2002 water season will be:

Garry Nielsen-----Main Creek
Erick Cummins-----East Ditch
David Funk-----West Ditch

Contract wages for Watermaster and Secretary/Treasurer were noted as being at \$5250 for Watermaster and \$650 for secretary/treasurer for the year of 2002. Garry Nielsen moved that they remain the same; 2nd by Bob Johnson. Motion Carried. There was some discussion concerning a possible compensation for the Watermaster for work done in the off-season. It was agreed upon that each year at the annual meeting if there had been an excessive amount of extra work this situation would be brought before the members and then voted upon as to how they desired to handle the compensation for this work.

The budget for the 2002 water use year was once again proposed to be \$6000. Garry Nielsen moved that the budget remain as proposed, 2nd Hal Frazier. Motion Carried.

Resolutions:

1. No change needed in meeting date.
2. Bills are due on May 15, 2002; no change here
3. Measuring devices must be in good working order or the Watermaster can refuse to deliver water until they meet proper standards.

Old Business:

Ken Mulberry once again brought up the weir on the west ditch and feels there is a definite problem with the ability to properly measure the water in that ditch. It was noted by the West Ditch users that some work had been done to improve this situation and worked quite well this past year because of the low water situation. It is true that the weir cannot measure all the water if it were to be put in there at one time. However, at this time, the ditch cannot hold all the water if placed in it at one time. This cannot be remedied until such time the West Ditch users can re-pipe the ditch around behind Lucy Gray's home. At this time they feel it is much too expensive to go ahead with the project.

Ken Mulberry once again challenged the fairness concerning water measurements and the records, of such. David Crockett, Chairman, called for an Advisory Committee study to be done on this matter and not try to solve it in a meeting. It was also agreed upon that if there is any major complaints or problems they should be brought before the Advisory Committee, at the time, and not at the annual meeting. The reason being, the complaint or problem does not affect all the members in attendance.

The minimum user amount was discussed and it was agreed to leave it at \$20.00.

Garry Nielsen made a motion to adjourn, Floyd Deadmond, 2nd. Meeting adjourned.
