Note 1. The Watermaster will be paid 50% of the maintenance fee. The balance, after deducting an estimate for office expense of \$20, will be paid the Secretary/Treasurer. Also, if "called" during the year, he will be paid \$25 for each call plus out-of-pocket expenses. The person calling (the caller) will be the person responsible for paying the fee. The Water District also has the option of placing the Watermaster on a monthly salary for any 30-day period, should it be deemed necessary during a water shortage period. If hired for a thirty day period, the Watermaster would be paid \$500 for any 30-day period hired. After the 30-day period, he would go back to being on a "call" basis, unless it was determined that he was needed for another 30-day period or fraction thereof. The "call" fee would be inapplicable during the 30-day hire period. If hired on a 30-day basis, a determination at the time of hiring would be responsible for paying the 30-day fee. Accordingly, because of the contingent nature of such a fee, it is not included in this budget.

Note 2. Only current water right holders of Water District 47G and nonconsumptive water users from Balanced Rock Crossing to the Snake River, on Salmon Falls Creek, are listed and are being charged a maintenance fee. Any water holders or reservoirs, waste water, domestic water wells, tributaries to Salmon Falls Creek and holders of applications to water rights have been excluded from such maintenance fee and are not included in the Water District 47G budget.

Note 3. These individual water right holders did not pay their assessment during 1995. They will be charged interest on the amount past due.

Note 4. These individual water right holders did not pay their assessment during 1993, 1994 and 1995. They will be charged interest on the amount past due.
