Dear Mr. Eckert;

We have received your 1996 watermaster's report, your 1997 proposed and adopted budgets, the minutes of this year's water meeting, the notarized oaths of office for you and Mr. Runyon, and a call-on petition for watermaster services. A copy of the approval page of the watermaster's report is enclosed. The only change that I made on the report and on the proposed budget was to cross out "24-hour" wherever the term "24-hour second feet" appeared. The amounts shown are flow rates in cubic feet per second (second feet) based on the water rights of district members. Since your watermaster normally does not actually deliver water, he cannot report delivery volumes like most districts do.

Your certificate of appointment is enclosed, and I will send Mr. Runyon his certificate. I applaud your efforts to better organize your district.


