Re: Water Rights Listing for Water District 47-C

Dear Jack:

Enclosed is a copy of a water right listing for Water District 47-C. Please note that there are two reports, one which contains ownership, priority date, diversion rate, source, acreage and uses, and one which contains comments which are indexed by water right number, current owner and source. Also enclosed is a water use code sheet. Please review the list and let me know if there are any omissions, mistakes, or discrepancies etc. I did not proof read the listing in great detail.

Please also note that I have included some Snake River Basin Adjudication (SRBA) claims. These claims contain an 'A' prefix and are shown for informational purposes only where rights were combined, or where a claimed was filed on beneficial use without benefit of an existing, recorded right. Rights should not be delivered according to SRBA claims unless there is some directive from IDWR. However, the SRBA beneficial stock water claims are probably permissible and should generally not be a problem.

The total acreage numbers are generally the total acres which were claimed in the SRBA. In some cases where the decree may have listed acreage, I showed the decreed acreage number under total acres and made a comment regarding the number of acres claimed in the SRBA. The diversion rate listed is the decreed, licensed or permitted rate of diversion (unless the record shown is an SRBA claim, i.e.; has an 'A' prefix).
