Re: Goose Creek Water District Meeting

Dear Water User:

A special meeting of State Water District 45-C, Goose Creek and tributaries, will be held September 27, 1994, 1:00 P.M., at the Oakley Canal Company office in Oakley.

The purpose of this meeting is to discuss reactivating the water district for ensuing irrigation seasons. Items to be addressed may include water district elections, adoption of water district budget and resolutions, state and interstate water rights, water rights regulation and water distribution, and potential orders by the Department of Water Resources regarding installation of measuring devices and controlling works on all diversions from Goose Creek and its' tributaries. Water users are reminded that Idaho Water District 45-C is confined to Goose Creek and tributaries within the state of Idaho. The watermaster of Water District 45-C can not regulate water rights across state lines.

All water users with diversions from Goose Creek and tributaries in Idaho are encouraged to attend this meeting. Failure of the water users to hold a water district meeting and elect a watermaster next year may result in the Department appointing a watermaster and fixing his or her compensation.
