Re: Water District Status and Annual Meeting, Water District 45-C,
Goose Creek

Dear Water User:

This is the time of year when our office contacts all of the state water districts and requests information regarding each district's annual meeting. Department records show that a meeting was held last year for District 45-C, but that there was no election of a watermaster or adoption of a budget. The District was inactive during 1993 and has been inactive for some time.

The purpose of this letter is to notify water users within District 45-C that the Department considers the district to be inactive and will therefore discontinue further correspondence regarding water district meetings, elections and adoption of budgets etc. This inactive status will continue until such time as either the water users or Department decides that an organized district is necessary. This does not preclude the opportunity for the water users to conduct future annual meetings for the purpose of electing a watermaster and adopting a budget. If the users want to conduct an annual meeting then they should notify the Department as to the date, time and location of the meeting at least 45 days prior to said meeting.

You should also be aware that Section 42-605, Idaho Code (copy enclosed) allows the Director of the Department of Water Resources to call a special water district meeting if he determines one is necessary. A special meeting can be held at any time during the year. If the Director determines a meeting is needed, then the Department will provide sufficient notice to all water right holders within the district. Section 42-605 also provides authorization for the Director to appoint a watermaster and fix his compensation if an annual meeting is not held and/or a watermaster is not elected.
