Jerry Stanger said the Oakley Canal Co. would pay \$440.00. Robert Bell made a motion that Marj Gorringer help with the books at \$150.00 this was seconded by Henry Calahan, and the motion passed. Tim Payton made the motion that Robert Bell serve on the flood board, this was seconded by Chuck Payton, and the motion
