Robert Bell made a motion that Marj Gorringe help with the books, at \$150.00. This was seconded by Robert Fehlman. The motion passed.

Walt Mullen, said that the Canal Co. would pay \$400.00 for the year of 1997.

Chuck was to check into the sales tax and repairs.

Tim was to check with the County Flood Committee.

Advisory Board members, Robert Manning, Chuck Payton, Robert Bell and Robert Fehlman Are to represent the lot.

Tim Payton made a Motion that the Secretary & Treasurer be the one to pay the bills. The Bank to use is Wells Fargo, in Burley, Idaho.

Bob Manning made a motion that all delinquent bills should be paid before water could be turned on, before March 25. Before water would be delivered by April 1997. This was seconded by Robert Bell. The motion passed.
