1. The budget for 1994 will be set at the assessment rate of \$3.00/minor inch.  
(\$150/24hr sec/ft.)
2. Salary for the watermaster will be set at \$2700 per year and he will pay  
the full amount of Social Security Tax.
3. Delivery of water will be refused to anyone who is delinquent in their  
payment of the proposed assessment.
