The meeting was called to order by Kay Wells, at 7:30 p.m., on January 25, 2000. Chairman Basil Fairchild was out of town. The meeting was being held at the Oakley High School, Oakley, Idaho. Members in attendance were Kay Wells, Jerry Marchant and Linda Zollinger.

Kay Wells called the meeting to order. Kay Wells made the motion to leave the board the same. With Basil Fairchild as chairman and Linda Zollinger as Secretary. Seconded by Jerry Marchant.

Minutes for the 1999 meeting were handed out and reviewed. Minutes were approved.

Nomination was opened for Water Master. Jerry Marchant nominated Lisa Beams and seconded by Kay Wells. Need to visit with her and see if she will accept the position as water master for the year 2000. Wages were set at \$3,000.00 for the water year and the water Master is to pay the full social security tax. The Water Masters duties will be for the full calendar year. Approved by all present.


Kay Wells discussed that all water bills must be paid, and all headgates, ditches, weirs need to be cleaned and repaired at each members location before their water is turned on. Approved by all present. Don Bedke did not pay 1999 water bill and needs to be collected.

Motion was made by Linda Zollinger to leave the assessment rate of \$3.00 per Minor Inch the same for the year 2000. Seconded by all present.

Workmen's compensation is to be paid for the year 2000. Approved by all present.

Water District 45A is up for review this spring. Records were sorted and handed out. It is the responsibility of each person to check and review his or her water rights.

No further problems to be discussed. The meeting was adjourned. Motion by Jerry Marchant and seconded by Linda Zollinger. Meeting adjourned.

1. The budget for the year 2000 will be set at the assessment rate of \$3.00/Minor Inch.
2. Salary for the Water Master will be set at \$3,000.00 per year. He or she will pay the full amount of Social Security Tax.
3. Delivery of water will be refused to anyone who is delinquent in his or her payment of the proposed assessment.
