RE: 1994 Adopted Budget, Water District 43-C

Dear Mrs. Ward;

We are returning your adopted budget for correction. You show a total budget of \$12,500., but your bottom-line total is \$11,837.69. I suspect that all the negative amounts shown for the various users is the cause of the discrepancy, although those amounts add up to more than the difference. The adopted is supposed to show the dollar value of the amount of water that is expected to be delivered to each user, so all amounts shown will be positive numbers. The affect of credits or debits from last year's watermaster report should not show up in the adopted budget, since the adopted budget is NOT a billing list.

I also noticed that some users are listed twice, with different budget amounts each time. This is OK, but it might be easier to list each person once, with only one budget amount.

We normally do not send out the oath of office forms until a satisfactory adopted budget is received in this office, but are enclosing these forms now due to the closeness of the irrigation season. Upon receipt of the signed oaths, watermaster and treasurer certificates will be issued.

RESOLUTIONS PERTAINING TO THE TIME AND MANNER OF COLLECTING THE BUDGET AS
ADOPTED AT THE ANNUAL MEETING OF THE WATER USERS OF

WATER DISTRICT No. 43-C

"That no ditch or canal company or other water user shall have the right to demand and receive water, and the watermaster shall not deliver to such person until the amount due and payable from such as fixed by the budget has been paid.

Said amounts shall become due and payable 15 days after receipt of water bills and said amounts if not paid, shall bear interest at the rate of 8% per annum. Also, the water user must present to the watermaster his paid receipt or other proof that his budget has been paid before he can demand his water."
