RESOLUTIONS PERTAINING TO THE TIME AND MANNER OF COLLECTING THE BUDGET AS  
ADOPTED AT THE ANNUAL MEETING OF THE WATER USERS OF  
WATER DISTRICT NO. 43-C

"That no other or Canal Company or other water user shall have the right to demand and receive water and the watermaster shall not decide to over stream until the amount due and payable from user as fixed by the Budget, has been paid. Said amounts shall become due and payable 15 days after receipt of water bill, and said amount, if not paid, shall bear interest at the rate of 8% per annum. Also, the water user must present to the water master his paid receipt or other proof that his budget has been paid before he can demand water."
