FIXED BY THE BUDGET HAS BEEN PAID. SAID AMOUNTS SHALL BECOME DUE AND
PAYABLE 15 DAYS AFTER RECEIPT OF WATER BILLS AND SAID AMOUNTS, IF NOT
PAID, SHALL BEAR INTEREST AT THE RATE OF 8% PER ANNUM. ALSO THE WATER
USER MUST PRESENT TO THE WATERMASTER HIS PAID RECEIPT OR OTHER PROOF
THAT HIS BUDGET HAS BEEN PAID BEFORE HE CAN DEMAND WATER."
