Dear Mr. Musser;

We have received your 2004 Watermaster's Report and 8 daily-record books, and your 2005 Proposed Budget. I noticed that the correct credit for Simplot is \$58.92, not \$50.92 as shown on the Report. I have corrected this minor error, and a signed copy of the approval page is enclosed for your records.

With regard to the budgeting question from last year's water meeting, a water district can choose just about any budgeting method it wants. Some districts use the 5-year average method, and the Proposed Budget form accommodates this. Some districts base their budget on the water rights owned by each user in the district, while other districts use last year's deliveries with no debits or credits. The Idaho Code does not specify a particular method. The advantage of the 5-year average is that it makes budgeting by each water user easier due to the reduced variation in costs from year to year (assuming that there are actually wet years when a lot of water gets delivered).

I have not heard of any watermaster training this year, but you will certainly be notified if anything is scheduled.

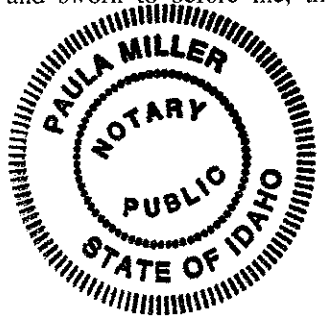
