That no ditch or canal company or other water user shall have the right to demand & receive water, and the watermaster shall not deliver to such person until the amount due & payable from such as fixed by the budget has been paid. Said amounts shall become due & payable 15 days after receipt of water bills and said amounts, if not paid, shall bear interest at the rate of 8% per annum. Also, the water user must present to the watermaster his paid receipt or other proof that his budget has been paid before he can demand water.
