PLEASE TAKE NOTICE that a formal hearing will be held on **January 12, 2005** beginning at **9:00 a.m.** at the Mackay Senior Citizen Center, 301 Cedar, Mackay, Idaho.

This hearing is being held in response to petitions for reconsideration and requests for hearing received by the Idaho Department of Water Resources' ("IDWR") regarding issuance of the Order for Distribution of Water, issued on July 12, 2004, and the August 23, 2004 Amended Order, Order to Show Cause, and Notice of Status Conference. These documents were issued in response to the Petition for Delivery Call filed by Jay V. Jensen, Jack A. Jensen, and L. Vaughn Jensen ("Jensens"). The Jensens' petition seeks the administration of ground water rights and surface water rights within Basin 34, specifically within Water District No. 34 boundaries for the Big Lost River.

If you plan to offer exhibits for the record at the hearing, note that Rule 606 of the department's Rules of Procedure requires that a copy be provided to each party and to the presiding officer.

The hearing will be held in accordance with the provisions of Chapters 2 and 17, Title 42 and Chapter 52, Title 67, Idaho Code, and the adopted Rules of Procedure of the department. IDAPA 37.01.01. A copy of the rules may be obtained from the department upon request or by accessing the


