Jensen has failed to produce any more water rights to justify his over diversion which he claims to have. Charles Isom has not made any contact at all .I would like to turn Isom and Jensen over to IDWR for further action.

I have also been presented with a list of possible causes of possible Expansion. I have looked at these and believe that the following warrant review by IDWR.

Don Spengler (Barbara J. Spengler Revocable Trust) Water Rights; 34-16, 34-44, 34-45, 34-254, 34-727, 34-2253, 34-2487 and 34-13410 located in T7N R25E Sections 21,27 and 28.

Jay Jensen Water Right 34-397 new half pivot which crosses into T5N R26E Sec.15 SENE & Sec.15NENE.

There is a few more that maybe we could look at that I have researched that possible just need to redefine their place of use on your next trip over.
