Based upon the foregoing, and for good cause appearing, IT IS ORDERED, ADJUDGED AND DECREED that the Motions and Objections filed by Plaintiffs are denied.

The Court further finds that the Motions and Objections filed by Plaintiffs are not frivolous, unreasonable, and without foundation, and the Court denies the request for an award of attorney's fees filed by BLRID and Intervenors.
