The annual water meeting held at the Rockland School March 3, 1997 was called to order by chairman Brent Walker at 1pm. Chairman Walker asked for the minutes of the previous meeting to be read. These were approved by motion of Kelvin Taysom, seconded by James Robinson. Chairman Walker asked for a motion to elect a Chairman and a Secretary/Treasurer for the next year. Motion to retain Brent Walker as chairman was made by James Robinson and seconded by Dick Nelson.
