Dear Mr. Robinson;

We have just received the minutes of your 1997 water meeting. Although you were again elected as watermaster of your district, we have not received your oath of office or a call-on petition for watermaster services as required by Sec. 42-600 of the Idaho Code. While we normally send out the necessary forms once the meeting minutes are received, it is ultimately your responsibility to meet the requirements for appointment as watermaster. If you deliver water without being appointed, you are not protected by the bonding authority of the State. You failed to meet these requirements in 1996, and were not appointed then either.

Please let me know whether or not you want to be appointed as watermaster of District 41. If you prefer to work as a private ditch rider only, I will not take steps to appoint you this year or in the future. If this is the case, we can consider your district to be inactive. Inactive water districts are not required to comply with the provisions of Sec. 42-600 of the Idaho Code, and do not have to submit any records of their activities to this Department.

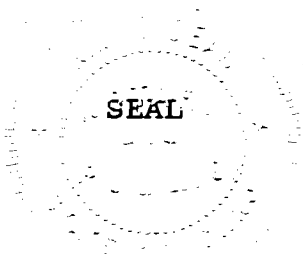
