As you may be aware, during the past year Mr. Ed Squires conducted aquifer tests of the geothermal ground water resource in the Stewart Gulch area. He would like an opportunity to share the data and his conclusions with the water users and other interested parties.

A public meeting is scheduled for 1:30 p.m. on Tuesday, August 23, 1994 at the upstairs conference room of the Idaho Department of Water Resources (IDWR) State Office at 1301 N. Orchard (near the connector freeway where Orchard approaches Fairview). You are invited to this meeting to learn about conditions monitored by Mr. Squires. Although the conference room is available for the entire afternoon, I imagine that the meeting can be completed in two hours or less.

I realize that this letter provides little advance notice and hope that you are not inconvenienced by this. However, useful information may be provided in this meeting that will facilitate water management decisions made by IDWR and the Watermaster if water shortages occur as normally experienced in late August or early September. This new data could affect the use of your well(s).

Mr. Squires' research occurred as a consultant for the Tertelings. I would like to take this opportunity to thank the Tertelings for making the new data available to the water district and IDWR. Their cooperation is greatly appreciated.
