I am reviewing your 1994 watermaster report for District 37-N, and have a question about the total amount of money due to you. This amount was not stated on the front of the report. While the adopted budget was \$19587., an additional amount is also shown on the watermaster report. You multiply the amount of second-feet delivered by \$1., then add additional amounts for the city lots on pages 3, 4, and 5, for a total of \$19720. Which amount are you claiming as the total due to you? I discussed this with Kathi Peck, but she was not able to confirm the correct amount. The adopted budget is normally what would be due to you; only the distribution among the different water users would change based on actual deliveries.

Thank you for your cooperation in this matter.

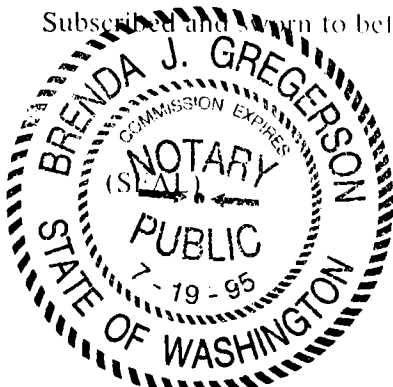
