ballot.

John Cenarrusa reported on weed problems in the area.

A budget of \$15,152.50 was proposed for the year 1995.

Total days and who should pay for water master when there is only

unanimously.

Harold Tolman moved the Advisory Committee be the Carey Valley  
Irrigation Reservoir Co. Inc. Board of Directors. Seconded by  
Robb Peck. Approved unanimously.
