

RESOLUTIONS PERTAINING TO THE TIME AND MANNER OF COLLECTING THE BUDGET AS  
ADOPTED AT THE ANNUAL MEETING OF THE USERS OF

Resolution #1

BE IT RESOLVED: To bill a surcharge of shortage above the budget according to the  
example as used in the letter from the Department of Water Resources dated 11/28/00  
signed by John Westra. Moved by Ray Smith, seconded by Paul Batrnel, passed unanimously.

Resolution #2

BE IT RESOLVED: That the amounts payable be each water user, as shown by the approved  
budget, shall become due and payable on March 15th and that said amounts, if not paid  
shall bear a penalty of 10% and shall bear interest from that date until paid, at a rate  
of 8percent per annum. BE IT FURTHER RESOLVED: That no water user shall have the right to de  
mand and receive water, and the Watermaster shall not deliver to such person until the  
amount due and payable for such user, as fixed by the budget, has been paid. Moved by  
Paul Batrnel and seconded by Althee Trail, passed unanimously.
