Your Watermaster Oath of Office has been received by the Department. Enclosed is your Watermaster Certificate of Appointment.



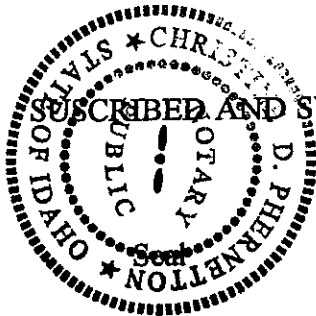
