Re: IDWR Field Visit to Diversions in Stanley/Challis Areas

Dear Water User,

Staff from the Idaho Department of Water Resources (IDWR) will be visiting **some** irrigation and other use diversions over the next several months within Water District No. 170 (Salmon River Basin above Ellis, including the Stanley Basin and Challis areas). The Director of IDWR created Water District No. 170 in March 2006. The first annual Water District No. 170 was held in April 2006. Water users present at the meeting elected IDWR to provide watermaster services until the next annual meeting in 2007.

The IDWR diversion visits will be part of an ongoing effort to inventory and evaluate diversions for controlling works, headgates and measuring devices. IDWR initiated some diversion site visits in the area last year. The effort during the first half of this year has involved gathering water right data and existing inventory information compiled by IDWR and other state and federal land use agencies. IDWR plans to complete the inventory in the Stanley Basin this year and the Challis area next year. Staff will not visit Challis, Garden and Morgan Creeks for this purpose since each of these creeks are in an existing water district or part of an ongoing project where information has been obtained about the diversions. Visits on the East Fork Salmon River and certain other creeks throughout Water District 170 will also be limited because information on diversions already exists for those sources.

IDWR staff also plans to make some miscellaneous diversion and stream flow measurements this year in the Stanley Basin. The inventory and field measurements are part of a first phase effort towards implementing measurement and reporting procedures in the water district. Stream flow and diversion measurements have also been scheduled within the next two weeks and later in the fall on the Salmon River and tributary streams upstream of Obsidian in the Stanley Basin as part of a stream channel study coordinated with the Forest Service and Sawtooth National Recreation Area. You may see IDWR staff in the Stanley Basin or other areas this year and in 2007.

This letter is to provide notice that IDWR and Water District No. 170 staff may be at your diversions or accessing private lands to reach diversions for inventory and measurement purposes. IDWR staff will contact owners directly if they need assistance or additional information.
