The annual meeting of the water users was held March 6, 1995 at 2:00 P.M. at the home of Dean Stokes. Those present were Dale Jolley, Dean Stokes, Bill Swahlen, and Gorden Kirschenmann.

The minutes of the 1994 meeting were read and approved.

ELECTION OF OFFICERS:

Dale Jolley was elected to serve a fourth year term as chairman. Gorden Kirschenmann to continue in the capacity as permanent secretary/treasurer. All water users to be members of the credentials committee.

1995 BUDGET:

A motion was made and passed by unanimous vote to collect a water assessment of \$700.00 for this year. No fee for secretarial work is to be collected. The watermasters salary was set at a flat fee for the year of \$700.00. The watermaster to start work April 1, 1995 and conclude work by November 1, 1995. The watermaster is to be responsible for all taxes and other expenses relating to his contract salary.

ELECTION OF WATERMASTER:

A motion was passed unanimously to again elect John Tracy as water-master. His duties to include weekly recordings of water use and be on call for any necessary adjustments for the water users.

OTHER BUSINESS:

Water assessments to be again calculated based on first rights as has been done in the past several years.


