
Dear Mr. Tracy:

March 3, 2003

- ◆ Call to Order by Chairman Jolley at 2 PM
- ◆ Minutes of 2002 meeting read and approved
- ◆ Finance report given by D. Stokes: account balance of \$258.16

 1. B. Stokes reported on the Lemhi Water District meeting on 2/25/03. Much discussion followed concerning high water rights and the need to file for such rights. J. Tracy was requested to provide records of high water usage in previous years so that Water District 74-C could file for the high water rights. These rights then would be utilized proportionately by the members of the water district. B. Stokes will meet with State Water Board representative when she is available here in Salmon.
