

ANNUAL WATER MEETING
MARCH 4, 1996
DISTRICT 74-A GEERTSON CREEK

The annual water meeting of Water District 74-A was held at the Boyd Stokes Residence at 7:30 PM.

Present were David Logan, Fran Tonsmeire, Boyd Stokes and Mike Kohl.

1995 minutes were approved as read.

During the discussion for selection of chairman and secretary, it was brought up that the same 4 people always attend the annual water meeting and have had to conduct the business of the water district for the past several years. Kohl commented he had heard remarks from various water users, stating that "You bastards always run the show the way you want to, to your benefit excluding everyone else." It was suggested by Kohl to elect those water users not in attendance to the various offices, and the "You Bastards" could stay home and criticize. Logan pointed out that if the other water users were not interested enough to come to the meetings, they probably would not be interested enough to conduct water district business.

Boyd Stokes was selected Chairman and Mike Kohl was selected Secretary/Treasurer for 1996. Both said it was the last year they would hold office.

The Watermaster's compensation for 1996 was approved as follows:

Watermaster Call Schedule 1996:

April 1 - Apr30	1 call weekly, or as needed
May 1 - Aug 1	3 calls weekly, or as needed
Sept 1 - Nov 1	1 call weekly. or as needed

Workman's Compensation was discussed. Kohl reported that a "Marrielle" of the Idaho State Insurance Fund, Idaho Falls, phone number 208-525-7287, stated that the premium was figured at \$7.95 for each \$100.00 of salary per employee of the district, but that the minimum premium was \$486.00. The discussion was tabled until further clarification by the State Legislature.


Resolved: All assessments are due and payable April 1, 1996. No water user shall have the right to demand and receive water, and the Watermaster shall not deliver water to such persons, until their assessments as set by the current budget is paid in full. The Watermaster will begin duties, as set by above schedule, on April 1, 1996 and end them November 1, 1996 or when all water user's are finished irrigating, whichever comes first.

Resolved: That when one water user has his water shut off, the watermaster will notify other users who may then want to use the water. High water to be equally divided among all water users who want to use it.

With no further business the meeting was adjourned.
