Watermaster Call Schedule 1995:

April 1 - Apr 30	1 call weekly, or as needed
May 1 - Aug 1	3 calls weekly, or as needed
Sept 1 - Nov 1	1 call weekly, or as needed

Resolved: All assessments are due and payable April 1, 1995. No water user shall have the right to demand and receive water, and the Watermaster shall not deliver water to such persons, until their assessments as set by the current budget is paid in full. The Watermaster will begin duties, as set by above schedule, on April 1, 1995 and end them November 1, 1995 or when all water user's are finished irrigating, whichever comes first.

With no further business the meeting was adjourned.
