**RE: LEMHI RIVER WATER SUPPLY BANK SURCHARGE FEE**

Dear Mr. Smith:

The purpose of this letter is to inquire when the Lemhi Water Rental Committee plans to submit the ten (10) percent surcharge fee to the Department of Water Resources ("Department") for rental of water from the Lemhi River Water Supply Bank ("bank") by the United States Bureau of Reclamation ("USBR") for use during 2003.

My files show that during 2002, the USBR paid a total of \$245,485 for the rental of water from the bank. In early July 2002, the committee paid the Department the administrative fee of \$21,007.80. In its May 21, 2003 letter to you, the USBR again offered to rent the same amount of water during 2003 for the same total price as for 2002. If the committee rented the same amount of water to the USBR, the administrative fee payable to the Department would again be \$21,007.80.
