
To: Idaho Department Of Water Resources.

As Water Master of Dist 74, I would like to make a request of the Dept. of Water Resources. Currently I measure all of the diversions in Dist 74 with a Swoffer flow meter. I have staff gauges fixed to the IDFG fish screens and have attempted to have rating curves. It is impossible to rate these diversions because of (moss, laterals, ditch maintenance, etc) below these staff gauges.

I would like for the Dept to issue an order to the water right holders of these diversions to have proper in stream measuring devices installed by irrigation season 2010. These diversion are locally called ( L-17, L-18, L-19, L-23, L-29, L-31B, L-33, L-38, L-42, L-45, L-47, L-49, L-50, L-52A, L-58A, L-58C, L-59, L-60, L-63, LBSC-1, LBSC-2, LBSC-3, LBSC-4, LBSC-4A, LBSC-5, LBSC-6 ) . Attached is a list of the users on each of the diversion. These diversions were selected as per the lowest raked on my list. I will be requesting another additional list for installation in 2011 at a later time.
