Re: Curtailment of Ground Water Diversion, Water Right No. 37-30000K, 37-30000L, 37-30011B, 37-30011C

Dear Water User,

The records of the Idaho Department of Water Resources (IDWR) show that you are the owner of the above referenced water right(s) subject to an approved transfer or permit authorizing diversion of ground water that is contingent upon the availability of surface water from the Big Wood River (or tributaries to the Big Wood River). Specifically, the above water right(s) includes a condition that limits the diversion of ground water to those times water is available for diversion under the right(s) and priority from the original source, Big Wood River (or tributaries). The right is also subject to regulation and control by the watermaster of State Water District No. 37, Big Wood River and tributaries

The Water District 37 watermaster has notified IDWR that the priority date of the above referenced water right(s) has been cut and is no longer available for delivery or mitigation purposes. Many water rights have been cut or cut earlier than normal due to drought conditions that have existed in your area this year. Currently, all water rights with a priority date after March 24, 1883 are completely cut. Rights with priority of March 24, 1883 are currently cut back to 50 percent.

The purpose of this letter is to notify you that you must immediately cease diversion of ground water and use under the above referenced water right(s) if such right(s) has a priority date after March 24, 1883. If your right is a priority of March 24, 1883 then you must reduce your diversion to 50 percent of the authorized rate. The water district watermaster will check for use under the water right(s) to insure that there is compliance with this notice as well as terms and conditions of the water right(s). The watermaster has authority to shut off any use that can not be delivered. Failure to comply with this notice and the conditions of the water rights or any further diversion of water made after the use is regulated may result in the issuance of a Notice of Violation and Cease and Desist Order from IDWR. Such orders may carry certain civil penalties. The watermaster will notify you if the priority date under your right(s) is deliverable again this year and if you can resume use of water from your ground water diversion.

IDWR and Water District 37 will appreciate your attention and cooperation in this matter given the existing drought conditions and less than normal water supplies that challenge all of us this year.
