MINUTES WATER DISTRICT 36A

The Water Users of Water District 36A met March 6, 1995, at the Hagerman High School for their Annual Meeting. 22 Water District members and 1 Idaho Department of Water Resource member were in attendance.

The meeting was called to order at 1:05 P.M. by Chairman John LeMoyné.

Minutes of the 1994 meeting were read by Deloris Jones, Secretary. The minutes were approved as read.

Motion by Bill Jones to nominate John LeMoyné as Chairman. Seconded by Ivan Gustafson. John Mavencamp moved that nominations cease. Carried.

John LeMoyné reported that the Advisory Committee met 3 times during the past year and was having difficulty coming up with a formula for assessing the members and collecting it.

George Lemmon, Water Master, reported that it was taking him about 2 days to measure the main diversions in the District and calculate the results.

Tim Luke, Idaho Department of Water Resources, reported that under the new measuring law users will have to measure once a week, non irrigators starting April 1 and irrigators when irrigation water is turned on. Reports to be made once a year.

A lengthy discussion followed relating to ways to make assessments, how many times the Water Master would check the diversions and make a measurement, if we should report as individuals or one report that the Water Master would turn in for 36A, would some people use the Water Masters measuring device instead of their own, etc. etc.

Tim Luke stated that this District is unique in that it has so many non consumptive users. He only wants a report from each diversion and it is to be filed once a year in January. Water Master does not have to spot check the measuring until after this first year unless there is a specific question regarding measuring.

George Lemmon, Water Master, said he has been figuring his rate of payment at \$10 per hour and 25¢ per mile.

Bill Jones moved that the rate per hour be increased to \$20. Died for lack of a second.

John LeMoyné read the list of head ditches (diversions) that the Water Master checks. There are 38 of them.



John Mavencamp moved that the Advisory Board meet and determine amount to be paid to the Water Master and make an assessment against the 38 diversions for this amount, and that the Water Master would receive \$20 per hour and 25¢ per mile for any specific times he is called out for disputes, etc and that this fee would be prorated between those involved in disputes or requesting services. Bill Jones seconded. Carried.

Motion by Lynn Babington that Deloris Jones be Secretary. Motion by Ivan Gustafson that George Lemmon be Water Master. Seconded. Carried.

It is understood that the Water Master for 36A is elected for a full year.

Meeting adjourned.
