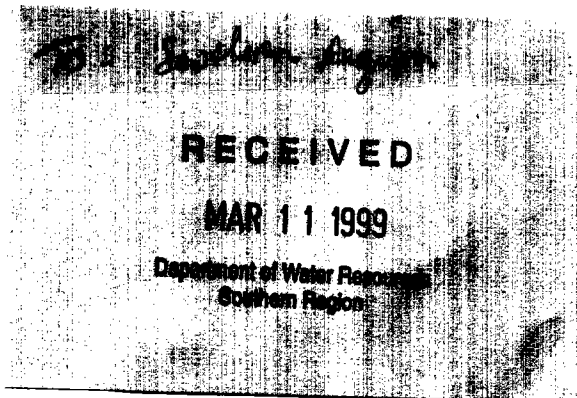

Members of Water District 36A met for their annual meeting March 1, 1999, at 1 p.m. at the Hagerman High School Ag Room. 9 members were in attendance.

John LeMoyne, Chairman, called the meeting to order.

Minutes of the Annual Meeting held March 2, 1998, were read by the Secretary. Minutes approved as read.

A Financial Report was distributed. Balance on hand in the Bank on February 28, 1999 is \$2236.66. 1 remaining assessment had been paid.

A Proposed Budget for 1999 was presented based on the \$2236.66 cash in the Bank. No assessment needed for the coming year. Bryan Kenworthy moved to accept this proposed budget. Lynn Babington seconded. Carried.

Water Master Frank Erwin reported that most of his calls this past year have been informational. New people needing information as to what and where is their water right.


Motion by Lynn Babington to elect Frank Erwin as Watermaster for the coming year. Seconded by Bill Jones. Carried.


