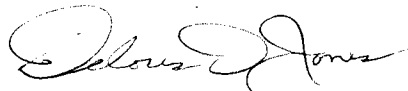

WATER DISTRICT 36A

Members of Water District 36A met for their annual meeting on March 6, 2000, at 1 p.m. at the Hagerman High School Ag. Room. 12 members were in attendance.

John LeMoyné, Chairman, called the meeting to order.

Minutes of the Annual Meeting held March 1, 1999, were read by the Secretary. Minutes approved as read.

Motion by Lynn Babington to nominate Dan Yore as Chairman for the coming year. Seconded by Bryan Kenworthy. Carried unanimously.

At the request of Dan Yore, John LeMoyné continued to preside for a short time.

A Financial Report was distributed. Balance on hand as of February 29, 2000 is \$745.46 plus \$70.00 service charge reimbursement if it clears in February or a total of \$815.46.

Motion by Ivan Gustafson to accept the financial report. Seconded by Dave Parrish. Carried.

A proposed budget for year 2000 totaling \$2195.00 was presented. Dan Yore made a motion that \$300.00 be added to this budget for Secretarial/Treasurer services. Bryan Kenworthy seconded. Motion carried to add this amount. Motion by Lynn Babington to approved the amended Budget totaling \$2495.00. Verl Bell seconded. Carried.

Bill Jones moved that an assessment be made following the same pattern as was used in 1997. Seconded by Dan Yore. Carried.

Dan Yore, new Chairman, continued the meeting.

John LeMoyné moved that the Advisory Board members for the coming year would be: Verl Bell, Ivan Gustafson, Lynn Babington, Cleave Lloyd and Bryan Kenworthy. Dan Yore, Chairman and Frank Erwin water master are automatically on this Board. Seconded by Bill Jones. Carried.

Motion by Bill Jones to elect Frank Erwin as Water Master for the coming year. Seconded by John LeMoyné. Carried.

Lynn Babington moved that Deloris Jones be elected Secretary/Treasurer for the coming year. Seconded by Verl Bell. Carried.

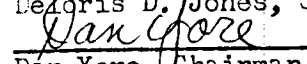
Lynn Babington will be the co-signor with Dan Yore on any checks. Water Master Frank Erwin reported it had been a quiet year.
