The Department has not received annual water measurement reports for the Brailsford Ditch for years 1998 through 2002. The Department records list you as the contact for submittal of annual measurement reports for the Brailsford Ditch. We have sent you several reminder notices in the past regarding delinquent reports. The last reminder notice was sent to you on May 21, 2001. If you are no longer the appropriate contact person for the ditch please advise us immediately.

The Department requests that you submit measurement reports for the Brailsford Ditch for years 1998 through 2002 to our office on or before May 15, 2003. Failure to submit the reports by the requested date will result in the issuance of a Notice of Violation and Cease and Desist Order. Please note that issuance of a Notice of Violation can result in monetary civil penalties pursuant to Section 42-1701B, Idaho Code.
